The 2019 AHIP curriculum launches today!

Producers may now access Part 1, the AHIP Medicare certification training curriculum. Take a moment to familiarize yourself with the instructions below.

AHIP Curriculum and Exams

The AHIP platform requires a negotiated fee of \$125 (That's a savings of \$50 off AHIP's standard fee of \$175!) To enjoy this savings, you will need to use this designated AHIP Medicare Training/HCSC link.

Producers will complete the following curriculum on AHIP's platform:

1. Medicare Basics Course
2. Medicare Marketing Course
3. Non-Discrimination Attestation
4. General Compliance & FWA Course and Exam
5. Final Exam

The AHIP curriculum must be completed by all individual producers and sub producers including agency principals. The HCSC/CMP link to the HCSC training will be provided on July 5 (tentative) in a separate email.

Note: Due to the AHIP curriculum launching prior to the HCSC curriculum, users can use the designated HCSC/AHIP link between June 18 and July 4 to access/complete the AHIP tasks at the HCSC discounted rate. After July 4, users may access Part 1 and 2 via the HCSC/CMP link.

AHIP Login Information:

- **User ID:** Individual National Producer Number (NPN) excluding leading zeros.
- **Password:** Previously created password.

The 2019 AHIP course will not be available after June 15, 2019 at 11:59 p.m. CT.

Producers who wish to complete the 2019 MAPD/PDP curriculum may instead take the 2019 AHIP course along with the 2019 Blue Cross Medicare Options Product course, exam and forms. After June 15, the 2019 product training will be available for all current producers on their to-do list, but only available for new producers upon request.
